Item 2	2. Results of the course/teacher evaluations, 2021-22
Item	The results from the evaluations of courses in M-ECON were presented.
information	These were separated into the required courses and specialty courses and

	The evaluations for required and specialty courses reflect a high degree of satisfaction among the M-ECON students. There were two courses that had scores less than 3,0. There is some cause for concern in the case of ECN380. In the other course, substitute teachers took over the course and mid-course changes were made to improve matters.

Item 4	4. New items
Discussion	4.1 Class size in ECN304 and ENC330
items	ECN304 (Behavioral and Experimental Economics) has 6 students enrolled and ECN330 (Economic Integration and Trade Liberalization) has 8 students. The Head of Academic Affairs noted that courses with fewer than 10 students are in jeopardy of being cancelled in the next academic year.
	4.2 Specialization in Agribusiness and Food Economics
	If ECN330 ceases to be offered, then one of the core courses of the specialization in Agribusiness and Food Economics is lost. Moreover, there are no students from the business side of the program who have expressed an interest in this specialization. There is serious concern that this specialization will not be viable beyond 2023-24 (allowing those in the specialization to complete it).
	4.3 Student Evaluation of M-ECON thesis supervisors
	4.4 Issues with use of Stata in ECN303 and ECN305
Proposed	ECN304 is an important quantitative analysis course that would be a serious
resolution	loss. One possibility would be to reduce the course to 5 ECTS to make it
	easier for students to fit into their schedule. This proposal was suggested by
	Silja noting that such a reduction would make it easier for M-ØA students to
	take it. If Stein would want to have a second half of the semester
	continuation of the course for another 5 ECTS that could/should be a
	possibility. The program leader reached out to Stein who in principle agreed
	that the course can be divided into two. There should be flexibility for Stein

to continue with the content as it is presently and for him to decide how to divide the course into two parts.

It was noted later that in autumn 2022 ECN304 collided with BUS340 (Supply Chain Management), a popular business course, on Fridays. This could be another relevant factor explaining the low course enrollment.

The head of academic programs noted that if Agribusiness and Food Economics cannot be made viable, then both ECN330 and the specialization will have to cease as an offer. Perhaps M-ØA and M-ECON program leaders can informally meet with M-ØA students to see why there is no appeal.

An evaluation form was developed to get feedback on the supervision and advising that students received during their research and writing. There were no students who completed the evaluation. Perhaps the form was uploaded onto the system to late or that students were not made sufficiently aware of the evaluation. Kateryna will look into including in on Wiseflow and making it a step that students must take during the uploading of their thesis. Students will be assured that evaluations will not be shared with advisors and will only use the results for assessing quality of supervision and advising.

It was once again noted that R and Python were dropped from ECN303 and ECN305. It is increasingly commonplace for students to voice their discontent with not having the more updated software packages in their quantitative analysis courses. Students on exchange at other universities have noted that Stata is no longer used there and neither is it used in work life. The program leader noted that this would be reflected in the minutes. This is not the first time that this has been brought to the council's attention. During the 2022 career evening arranged by the School, two of the four former M-ECON graduates who presented strongly recommended that students learn Python and noted that Stata was not a program they used.
